Dear Mr. Reig Rodrigo,

Thank you very much for your message, we fully understand the circumstances with the COVID-19 pandemic and the impact on EU initiative timelines. Challenging times ahead.

We wanted to come back to you to explain the rationale for requesting a meeting with you in more detail. Syngenta has already committed \$2 billion over five years to innovation specifically targeted at delivering a step change in agricultural sustainability. They are accelerating their research and development programme as a result, and Syngenta's Senior Management would very much welcome your views and advice on the direction of travel that the company is taking, to help ensure that this substantial investment will fit with EU, and particularly your Commissioner's, priorities and expectations. We believe that a discussion would be more helpful than exchanges of documents, especially as some of the information from Syngenta may be commercially confidential.

Syngenta is an active participant in the trade association ECPA, and are indeed very aligned on core messages. It is essential that this industry is part of the solution and working in tune with all parties, including the Commission and farmers. However, the path towards more sustainable agriculture will be driven by individual companies that are investing in bringing innovations to farmers. Due to anti-trust law compliance, individual companies cannot share sensitive information on innovation with the trade association. This is why, we would very much appreciate a video call conversation with you.

Do you think it would be possible to have a short video discussion with you to seek your advice on Syngenta's future roadmap towards more sustainable agriculture? Recognising that you have overarching priority work on COVID19 response we will of course be completely flexible to meet your availability.
